Pursuant to Article 17 of the General Terms and Conditions of Travel, the representative of “Vojvodinašume” Public Enterprise and “Vojvodinašume-Turist” Travel Agency Branch Office, as of 09 March 2020, establishes the following:

## **SPECIAL TERMS AND CONDITIONS OF TRAVEL IN HUNTING TOURISM**

### **1. RESERVATION OF A HUNTING TRIP:**

Hunting dates are reserved only after an advance payment confirmation is received in accordance with the pro forma invoice issued by “VOJVODINAŠUME” Public Enterprise, “Vojvodinašume-Turist” Travel Agency Branch Office. In the event that a client fails to make an advance payment within the time frame stipulated in the pro forma invoice, he or she will be considered to have withdrawn from the reservation for the requested time period and game for hunting. The current Price List for the game shooting and hunting services contains the sums of advance payments for individual hunting on big and small game.

The reservation should include the following:

- name and surname of each hunter
- address and place of residence
- date of birth
- passport number and expiration date
- weapon licence number and expiration date
- type of hunting and the number of hunting days
- accommodation (a hunting lodge or hotel, room type)
- arrival date and time (an aeroplane or a car)
- information on hunting weapons (type, serial number, caliber)
- telephone and fax number of a contact person

If the reserved hunting is cancelled no later than 60 days before the start of hunting, 50% of the value of the advance payment is reimbursed and if it is cancelled within the period of 60 days, the whole amount of the advance payment is retained.

### **2. RIGHTS AND OBLIGATIONS OF THE ORGANISER:**

The organiser is obliged to :

- acquaint the hunter with the travel programme and the current Price List for the game shooting and hunting services, as well as the abovementioned special and general terms and conditions of travel,
- provide the foreign hunter with the appropriate invitation letter (containing personal information of each hunter and weapon information which the hunter brings with him or her),
- to provide the hunter with a trophy certificate for all trophy game that he or she shot, and to additionally award the hunter a medal (gold, silver, bronze) for the trophies in the category of medals.

The organiser is entitled to make any necessary changes regarding previously organised accommodation so that hunting could be properly conducted in accordance with the current terms and conditions for hunting in the hunting grounds.

The organiser is not obliged to provide the citizens of other countries with travel regulations (visas, customs duty, health regulations and the like) which are in effect in the transit country. The hunters are held responsible to duly obtain all necessary documents in accordance with the terms and conditions.

### **3. PRICE OF SERVICES:**

Individually presented values in the Price List for the game shooting and hunting services are net amounts, expressed in dinars (RSD) for "Vojvodinašume" Public Enterprise hunting grounds. VAT is charged to all the prices at the current rate in the Republic of Serbia. Hunting is charged in dinars and if the invoice is paid by remittance from abroad, the calculation is made by the conversion of the prices in dinars into the prices in euros at the official exchange rate of the National Bank of Serbia on the date of invoice issuing. For the hunting grounds of hunting associations, the prices are expressed in a foreign currency (EUR) and payments are made in dinars applying the official exchange rate of the National Bank of Serbia DIN-EUR, on the day of invoice issuing. The current Price List for the game shooting and hunting services contains discounts to big game shooting within and beyond a certain trophy category as well as to big game shooting without a trophy in individual hunting during the whole hunting season or a certain time period.

### **4. TRAVEL AND OTHER DOCUMENTS:**

Before the beginning of a hunt, each hunter is obliged to have the following valid documents with him or her: **passport**, hunter's card of the Republic of Serbia for the current hunting season and weapon licence. If a hunter does not possess a hunter's card, it is possible to purchase it in the hunting ground before the hunting begins.

### **5. WEAPONS:**

In order to bring hunting weapons into the country on a temporary basis, the hunter is obliged to provide an invitation letter issued by the organizer and is allowed to bring not more than three hunting rifles of different calibers. The hunter pays the fee for the transfer of weapons into the country at the border crossing. If the hunter who temporarily brings the weapons into the Republic of Serbia is coming by plane, the help of the organiser's assistant is required at the airport. The hunter's personal weapon is required to correspond in caliber to the ammunition used for the hunted game in accordance with hunting practices and ethics. A foreign hunter is obliged to declare hunting weapons and ammunition at the border crossing on entering Serbia.

### **6. TROPHY EXPORT AND VAT RETURN:**

The required documentation for trophy export is as follows:

- payment confirmation/invoice
- trophy certificate
- trophy export permit
- veterinary certificate and
- certificate which certifies that the trophy is not subject to the export ban

Foreign tourists-hunters are entitled to VAT return for the shot trophies, which, after hunting, are exported from the country in their personal luggage. The trophy value inclusive of VAT must be at least 6.000 RSD (aprox. 51 EUR). VAT return procedure is conducted pursuant to the regulations of the Republic of Serbia.

## **7. ENTITLEMENT OF HUNTERS TO COMPLAIN:**

About the incomplete service provision regarding hunting; in the event that the hunter has any complaints regarding hunting services, the organization of expert escorts in hunting, the realisation of hunting, he or she is obliged to inform the responsible person about that during or immediately after hunting. If the complaint relates to the possible imprecision regarding the trophy value on the part of the expert escort before shooting, which results in the shooting of the game of the trophy value which the hunter has not agreed about before hunting, the hunter is obliged to request the opinion of the expert commission which is to be formed in the very hunting ground and which will consider the complaint on that very day. Complaints about incomplete service provision regarding hunting that are subsequently submitted, will not be taken into consideration by the organiser because such complaints are to be submitted on the spot to the responsible person for the hunting ground.

The abovementioned Special Terms and Conditions have been effective since 18 March 2020 and relate to the particulars which are not stipulated in General Terms and Conditions of travel as of 09 March 2020.
