PUBLIC INVITATION NO. 2

For the submission of tenders in the open public procurement procedure for the goods:

- FUEL IN THE YEAR 2019 -

The object of the public procurement is **FUEL IN THE YEAR 2019 in the open public procurement procedure.**

General Vocabulary of procurement:

- fuel – 09100000;
- diesel fuel -09134200;

The description, quantity and other characteristics of the public procurement of goods is defined in the tender documentation.

Conditions for participation: All interested tenderers fulfilling the obligatory conditions for participation in the public procurement procedure, in accordance with the Article 75 of the Public Procurement Law, shall have the right to participate. A tenderer shall prove the fulfillment of the conditions by submitting documents referred to in Article 77 of the Public Procurement Law, in the way explained in the tender documentation and this public invitation.

The criterion for the choice of the most favourable offer is the **economically most favourable** one.

Time and place of the insight in the tender documentation: all interested tenderers will have the direct insight in the tender documentation at the Portal of the Public Procurement and website Purchaser.

Time and place for tenders submission: the tenders should be submitted up to **19.03.2019, untill 9:30 hours.**

The tenders should be submitted in a sealed envelope by mail or directly at the address: JP „Vojvodinašume“, Petrovaradin, Preradovićeva 2, with the following notice: „Ne otvarati – ponuda po pozivu za podnošenje ponuda broj 2, GORIVO 2019. god.“ (DO NOT OPEN – public invitation **nr. 2 – FUEL in the year 2019**), with the name, the address and telephone/telefax nr. of the tenderer on the back, or to affix and fill a form taken over from the tender documentation.

The content of the tender and the necessary enclosure are defined in the tender documentation. The tender must be submitted on the original form of the tender documentation.

Time and place for the public opening of tenders: the public opening of tenders will be performed immediately after the deadline for submission is expired, i.e. on the date and time stipulated in the tender documentation, at the address of JP „Vojvodinašume“, Petrovaradin, Preradovićeva 2. The representatives of tenderers have to submit the authorisation for representation to the Commission for public procurement at the opening.

The deadline for decision on the choice of the most favourable offer is no longer than 25 days from the date of the public opening of tenders. The decision will be delivered to all the tenderers within the following 3 (three) days.

The Contract will be signed within 8 days after the deadline for the rights protection from the article 149. paragraph 6. of the Public Procurement Law.

The purchaser has the right to suspend the public procurement procedure, according to regulations prescribed by the Law.

Any additional information regarding this public procurement can be obtained on weekdays, from 7:00 to 15:00 hours.
