Award notification:

The successful tenderer will be informed on the results of the evaluation procedure in written form.

Address and meanings for submission of the tenders:

The tenderers must submit their tenders using the attached **submission form.** The tender will be submitted in **1 original or via e-mail, signed and scanned**. Any tenders not using the prescribed form will be rejected by the contracting authority.

The tenderer is required to provide the following supporting documentation:

- CV of expert/s according to the template provided
- Copy of Registration document or copy of extract from register APR

The tenders can be submitted in sealed envelopes, containing the following information:

2. SELECTION CRITERIA

Financial capacity:

 The average annual turnover of the tenderer must exceed the annualized maximum budget of the contract i.e., RSD 900.000,00 divided by the initial contract duration in years, where this exceeds 1 year;

Technical capacity:

• The tenderer has provided project management and/or preparation services with a budget of at least RSD 900.000,00 accumulated from maximum three contracts, which was/were implemented at any moment during the past three years.

The tenderers are reminded that the maximum available value of the contract is RSD 900.000,00 gross amount.

5. ADDITIONAL INFORMATION

Confidentiality

The unsuccessful/successful tenderers will be informed of the results of the evaluation procedure in written form. The estimated time of response to the tenderers is 7 days from the deadline for submission of tenders.

Award criteria²

The contract will be awarded to the tenderer that submitted an administratively and technically compliant tender and offered the best value for money. Technical offer will be considered with the weight of 80% and financial offer will be considered with the weight of 20% during the evaluation.
